Likewise, a valid forum selection clause, unlike a choice of law clause, may act as a waiver to objections to personal jurisdiction. Properly drafted forum selection clauses are prima facie valid and presumptively enforceable because they allow parties to designate, in advance, the forum in which their dispute will be heard.

A mandatory forum-selection clause typically designates an exclusive venue or jurisdiction for litigation arising out of a contract. 3 Forum-selection clauses can be either geographical (mandating a particular location) or jurisdictional (mandating a particular court). 4 Based on this

Supreme Court held that a forum-selection clause requiring suit in Wisconsin state court was unenforceable because “agreements in advance to oust the courts of the jurisdiction conferred by law are illegal and void.” Texas courts likewise disfavored forum-selection clauses as “ousting” courts of jurisdiction.
